What assistance or resources would help you to take the next steps around Repairing the Breach?	Packaged online programs like Sacred Ground and educational video resources like those prepared on the Doctrine of Discovery are very helpful.
	It would be very helpful to have more resources developed on the issue of how land appropriation and development is connected with reparation and reconciliation. Further development of resources that connect Repairing the Breach with climate justice.
