That work has already begun with tilling the ground through conversations with those in leadership in ECMN.

# Please describe these Truth and Reconciliation process efforts:

We have several efforts underway in ECMN that are new, and a historic commitment to this work. We have created and engaged formation around the Doctrine of Discovery and truth telling as it relates to ECMN's history with the native peoples of Minnesota. Part of ECMN's diocesan budget is allocated to supporting our native congregations and ministries as a commitment to repairing harm as well as investing in the vision for these communities.

In the past 5 years, we have engaged this work in a variety of ways, including formal courses focused on the IDI, which are required for all those going through our School for Formation and open to all leaders in ECMN, as well as countless workshops and events focused on racial justice and creating the beloved community.

After the murder of George Floyd and the trials of the police officers who committed the murder, ECMN has developed liturgies of lament and created and participated in spaces that provide an opportunity to lament, re-commit to the work of racial justice, and do so alongside other Episcopalians and members of the Minnesota community.

Recently, we have begun working with Heidi Kim and The Rev. Dr. Catherine Meeks to develop a formation resource specific to ECMN that helps Episcopalians in Minnesota connect their theology to the work of racial justice and healing, investigating the history of the state and diocese, and committing to the work here and now.

Several clergy and faith communities participated in public lament services following the riots and unrest after the murder of George Floyd. ECMN held a zoom lament services as well. Several of our clergy and lay leaders have started preaching and continue to preach on racism in our State. We launched the Bishop's Book Club and 4 books were on racism topics and several other faith communities have started book clubs on books relating to racism and specifically racism in MN.

Through our Weekly Newsletter and the Bishop's intro to that News Letter, we have shared stories from around MN on Beloved Community.
