We held several virtual meetings within the last 12 months related to flooding the historically Black Raleigh neighborhoods because of upstream development. We've partners with the Industrial Areas Foundation (IAF), national environmental non-profits like the Conservation Fund and the US Water Alliance, governmental entities such as the Raleigh City Council, the Planning Commission, and Raleigh's stormwater commission. We recently received a grant from The Episcopal Church to address environmental racism.
