We have also started a monthly ministry on the church lawn: "Silent Vigil Against Racism." In which we hold signs and hold our hearts in prayer around the violent and death-dealing realities of racism in our own communities and lives.

I suppose the programs I've outlined for St Thomas & Grace really fall into this category! We have had two members of leadership participate in Sacred Ground circles (as a part of a diocesan-wide initiative). Both also went through a few training sessions to become leaders for Sacred Ground. We're also exploring the "From Many One" model of sharing stories about race and racism. I frequently (at least 1/month) preach about racism, and my others sermons are structured to engage with the "White Supremacy Culture" elements from SURJ in order to help us (we're a 99.9% white congregation) unpack our cultural assumptions together.

I think we're actually doing the most in this area!
