Anti-racism, dismantling racism training: One Human Race has continued to do this throughout the pandemic.

We developed an Interfaith Vigil for Voting Rights with a litany. We continuously to write Prayers of the People that are responsive to the events of the day.

St. James' Reads is a congregational reading program for adults. This year we have read Bp Curry's book, In My Grandmother's House, On Juneteenth, Dark Testament. We also did a Lenten Series raising the voices of Black Women Mystics like Sojourner Truth, Thea Bowman, Fannie Lou Hamer, Jarena Lee, and Octavia Butler. Our children's and youth ministries have also developed materials: e.g. Godly Play lessons on Pauli Murray and the Founders of St. James'. We seek to get young lay preachers of color into our pulpit, and preaching addresses the challenges of multicultural life lived together in the midst of inequalities.

Our 501(c)3 Welcome Table is doing some ABCD work as we seek to minister with the elderly facing economic scarcity in our gentrifying historically black neighborhood. We are starting to get more engaged with the Poor People's Campaign and addressing economic inequality. We work with Casa Marianella closely - a refugee serving organization. Freedom Schools, a ministry of our (c)3 serves underserved elementary school students and their families. We have expanded this Children's Defense Fund Program, which is the only one of its kind in the Austin area.
