Members in our parish have participated in local summer gatherings to protest racial discrimination, learn more about issues affecting the community, state and nation. Evolving from the preceding, members of the parish have joined with others in the community in researching and contributing to the establishment of a Historic Marker honoring the first locally elected African American Sheriff, who probably was also the first Black Sheriff in Vermont--Stephen Bates of Vergennes, sheriff from 1879-1907. The dedication of the Historic Marker will be on October 3rd and will include participation of African American relatives, who also participated in the work of the Historic Marker Committee.
